5. Vendor Booths committee has right to refuse booth to anybody.
6. Neither WKC 2010 nor the convention center shall be responsible for loss or damage occurring to the exhibits from any cause. No Insurance will be provided by AKKA WKC 2010 or Conference Center. If insurance is desired the exhibitor must obtain it.
7.
